Fund and Market Commentary

The global equity market as measured by the MSCI World Index rose by 4.48% over December while the Alpha Global Opportunities Fund lagged. Over the longer term the Fund has achieved competitive performance relative to its benchmark.

Italy has voted against constitutional reform following a December referendum forcing the Italian Prime Minister, Matteo Renzi, to resign leading to fears that Italy may leave the Eurozone threatening economic stability. The news initially put downward pressure on European equity markets although they quickly recovered, with the monthly return for Italy's MIB index up by 13.61%, FTSE 100 rising 5.29% and Germany's DAX growing 7.9%.

Investors have been enthused by Trump's promises of economic stimulus and the economic outlook increasing the attractiveness of equities. United States (US) equity markets continued to make gains over December with the Dow Jones returning 3.34% during the month, and the index falling just shy of 20,000 while the S&P 500 jumped 1.82%. The US unemployment rate rose to 4.7%, from a nine-year low of 4.6% last month and non-farm payrolls increased by 156,000. The US Federal Reserve hiked the interest rate by 25 basis points to 75 basis points, the first increase during 2016. In Asian markets, Japan's Nikkei 225 index notched a gain of 4.4%, while Hang Seng Index and China's Shanghai Composite fell 3.46% and 4.5% respectively. The Australian Dollar (AUD) depreciated by 3.18% to end the month at 0.7236 United States (US) cents.

Considering the prospects for assets beyond short-term noise and volatility, our preference is to take a longer term approach to the markets. This does not mean we are not actively managing the Fund. To the contrary, the structure of our Fund is always reflective of our most current assessment of market risk. In structuring the fund, Alpha Fund Managers seek to select high quality managers and blend these managers to create portfolios that can achieve consistent, absolute and relative performances, irrespective of where we are in the market cycle.




Returns (net of fees) versus Benchmark



The Alpha Global Opportunities Fund seeks to outperform the MSCI World ex Australia index consistently. The Fund will invest in a diverse range of globally listed securities as well as taking advantage of active country and asset allocation.

Alpha Fund Managers seek to achieve the stated investment objective by the blending of a small number of high conviction investment managers, each with a different investment process, in a complementary manner so as to produce consistent outperformance with risk similar or less than the fund's benchmark.
